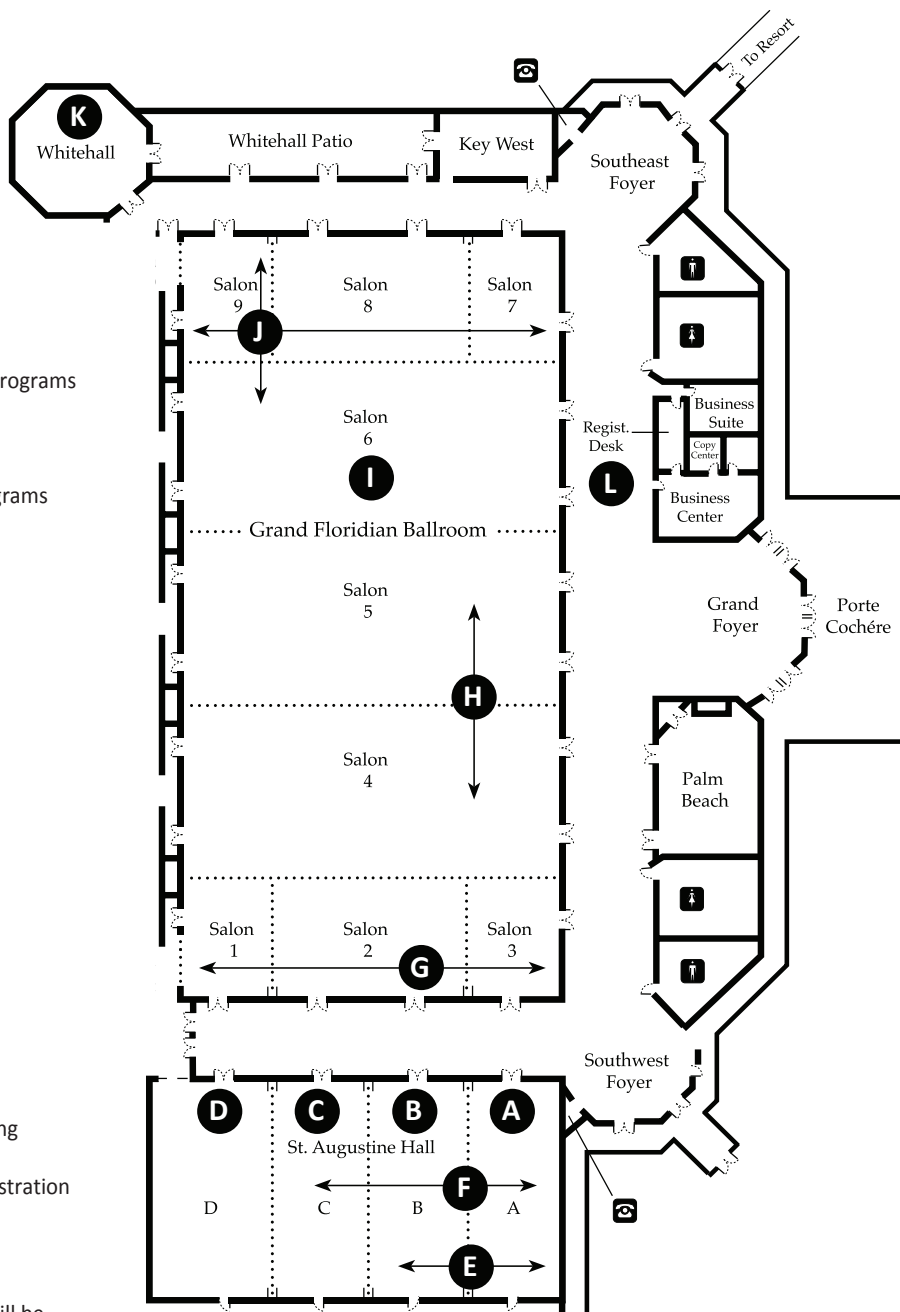

Target Audience

- c. **Pharmacists:** Pharmacists received in their materials packet a ***Pharmacist Agenda*** designed specifically for use in planning and documenting their attendance at the various activities. It contains information on the ACPE contact hours and the session groupings for Florida Board of Pharmacy Consultant Pharmacist Licensure Renewal contact hours. It also includes a code the pharmacist will need to use when claiming credit online.

While the ***Pharmacist Agenda*** is for the pharmacist's convenience to keep track of session attendance, it does not replace the pharmacist's online attestation that leads to credit. Within one week of the close of the conference, pharmacists will receive an email from USF Health with a link to complete an online evaluation, take a short post-test, and claim credit. If any pharmacist has not received such a link, he or she should contact USF Health at cpdsupport@health.usf.edu.

Please Note: Pharmacists do not need to complete the activity evaluation provided by FMDA, as pharmacists will complete a short evaluation online when attesting to their pharmacy credit. USF Health will forward the pharmacists' aggregate evaluation data to the conference planners on the pharmacists' behalf. **Pharmacists will not receive a tracking sheet or certificate of attendance from FMDA.**

- d. **Nursing Home Administrators:** Administrators should complete the course evaluations and tracking sheet, which is also the certificate of attendance, and deposit them in the box at the registration counter at the end of their last day.

Dheeraj Mahajan, MD, FACP, CMD, CIC, CHCQM

Session 118: Innovative Approaches to Implement Evidence-Based Deprescribing Practices

Dr. Dheeraj Mahajan is president and CEO of Chicago Internal Medicine Practice and Research and leads its affiliated group of companies; clinical associate professor of medicine, University of Illinois at Chicago; and attending physician in the geriatrics fellowship program at Edward Hines Jr. VA Hospital. He is a fellow of American College of Physicians and board certified in internal medicine and geriatric medicine. Dr. Mahajan is a certified medical director, certified physician advisor in utilization review and health care quality management, and is certified in infection control and epidemiology. She has served as the project lead for the implementation of the Quality Indicator Survey (QIS) in Florida since 2006 and is certified as a CMS Quality Indicator Survey Trainer. In 2009, she received the Survey & Certification Achievement Award presented by the CMS, for high-quality work implementing the QIS process in an early pilot state. Smoak is also a certified CMS instructor for the federal Basic Long-Term Care QIS survey process. In 2009-10, she was part of a group of surveyors in Florida to work on the development of the QIS Federal Basic Long-Term Care, which has been in place since August 2010.

Richard G. Stefanacci, DO, MGH, MBA, AGSF, CMD

Session 109: Innovative Solutions to Address Our Needs

Dr. Richard Stefanacci has focused his career on improving health outcomes, especially for some of the most vulnerable populations. He has more than 500 publications and has delivered well over 1,000 lectures, both nationally and internationally, focused on improving health outcomes. He is actively engaged in leading population health activities for numerous health systems and payer groups.

A board member of the American Society of Consultant Pharmacists (ASCP) and the Foundation for Post-Acute and Long-Term Care Medicine, he is an honorary lifetime member of ASCP and the National Association of Directors of Nursing. He is a fellow in both the College of Physicians of Philadelphia and American Geriatrics Society and was awarded the Humanism in Aging Leadership Award from the University of New England.

Dr. Stefanacci's work for vulnerable populations is very personal, stemming from his involvement with the Go4theGoal Foundation (www.Go4theGoal.org), a 501(c)(3) public charity he founded with his family and friends when his oldest son, Richard, was diagnosed with Ewing's sarcoma. Since its inception, the foundation has raised several million dollars to assist hundreds of children affected by cancer at nearly 100 children's hospitals across the country, while also funding cutting-edge research to find a cure. This research work is directed by the foundation's panel of experts, which includes several current and past federal government leaders in rare diseases.

Jeanne Y. Wei, MD, PhD

Session 125: New Guidelines for Hypertension from the Lens of PA/LTC Medicine

Dr. Jeanne Wei is the Jackson T. Stephens Professor of Geriatrics, chair of the Reynolds Department of Geriatrics in the University of Arkansas for Medical Sciences College of Medicine, and executive director of UAMS' Donald W. Reynolds Institute on Aging.

She has more than 30 years of experience in caring for patients; training future geriatricians, gerontologists, and cardiologists; conducting geriatric and gerontological research; as well as mentoring geriatric clinical and research fellows, junior faculty members, and developing academic programs and initiatives. Board certified in internal medicine, geriatrics, and cardiovascular medicine, she sees patients in the Thomas and Lyon Longevity Clinic in the Institute on Aging.

After obtaining MD and PhD degrees from the University of Illinois, Dr. Wei completed an internal medicine residency and cardiology fellowship at Johns Hopkins and a staff fellowship in gerontology at the National Institutes of Health/National Institute on Aging in Baltimore. She joined the faculty at Harvard Medical School and Beth Israel Hospital in Boston, where she became director of the Division on Aging at Harvard and chief of the Gerontology Division at Beth Israel Deaconess Medical Center. She was recruited to UAMS in 2002.

Dr. Wei has received continuous NIH funding for more than 30 years. Her major research interests include the aging cardiovascular system. She has served on NIH/NIA peer review study sections and was chair of the NIA Board of Scientific Counselors. She has served on advisory boards of research foundations, pharmaceutical companies, and the FDA. She holds six patents, has published more than 200 scientific articles, served on multiple editorial boards, is a reviewer of 36 peer-reviewed scientific journals, and authored six books.

The recipient of two UAMS College of Medicine graduate school mentor awards for serving as a major PhD graduate advisor and the UAMS College of Medicine Distinguished Faculty Award for 2016, Dr. Wei was elected as a fellow of the Gerontological Society of America (GSA) and was secretary of the GSA Biological Sciences Section. She received the Outstanding Clinical Educator Award from Harvard Medical School in 2000, the Outstanding Woman Faculty Award from the UAMS College of Medicine in 2005, and three Red Sash Awards from UAMS College of Medicine.

Chad Worz, PharmD, RPh

Session 113: National Leaders Forum

Dr. Chad Worz received his doctor of pharmacy degree from the University of Cincinnati. He developed an innovative clinical practice in the long-term care setting in Ohio and directed the pharmacy practice of a regional, independent pharmacy serving 10,000 residents in long-term care.

In 2007, Dr. Worz established Medication Managers, whose mission is to educate and serve nursing home residents, nursing home administration, long-term care pharmacies, and the public through a comprehensive knowledge of medication use, geriatric pharmacy, and the systems that manage the pharmaceutical care of the elderly in the United States. He has been a member of the American Society of Consultant Pharmacists (ASCP) since 1998, and recently served as president of the society's board of directors. In April 2018, He became executive director and chief executive officer for ASCP.

Robert A. Zorowitz, MD, MBA, CMD

Dr. Robert A. Zorowitz is a graduate of Albany Medical College. In addition to his certification as medical director by the American Board of Post-Acute and Long-Term Care Medicine, he is a fellow of the American College of Physicians and American Geriatrics Society.

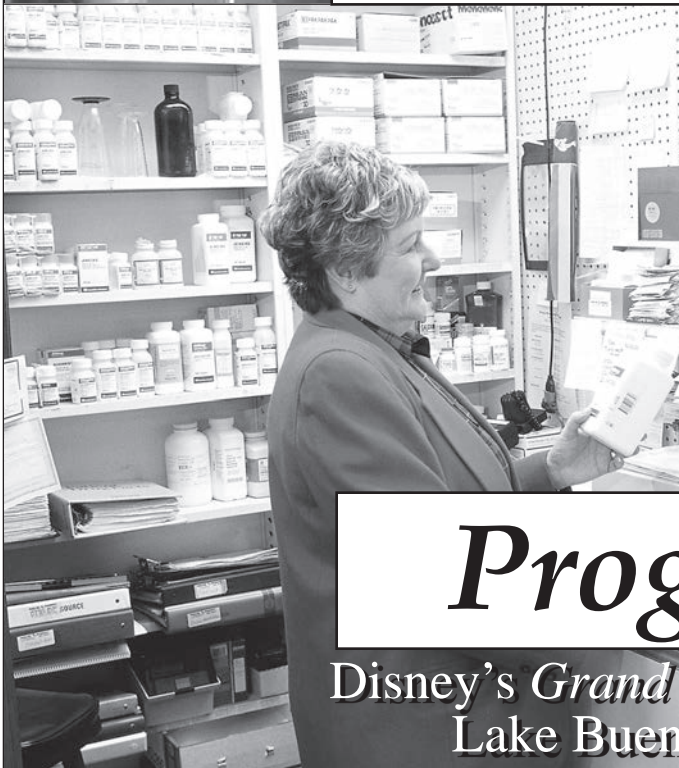

107 - Physician Orders for Life-Sustaining Treatments (POLST): Honoring Choices

1. Geriatric Medical Education, Clinical Care, and Health Care Finances

Stephanie Mathews-Brashear, MSN, Doctoral Student of Nursing Services in Adult Gerontology at the University of South Florida

The FMDA talk will center on the educational deficit for medical provider students in the development, learning, and clinical implementation of care regarding the U.S. geriatric population. Due to high incidence of litigation with medical providers and the increased clinical complexities of the geriatric population, over-testing has become mainstream, leading to increases in hospitalization and unnecessary medical interventions that may not increase longevity of the patient or quality of life. Can implementation of geriatric learning module improve the clinical care of nurse practitioners, reducing both unnecessary diagnostic testing of the elderly and, ultimately, its financial burden on the health care system?

Bio: Stephanie Mathews-Brashear has been an adult gerontology nurse practitioner for more than 10 years, specializing in adult endocrinology. In 2017, with the support of an MD collaborator, Brashear Geriatric Medicine was incorporated, with a focus on long-term geriatric primary care management, solely in assisted-living facilities.

Mathews-Brashear has been a clinical and academic adjunct faculty at the University of South Florida in the Graduate Nurse Practitioner Program for the past 1.5 years. Her formal education includes a master's degree in health management and a post-master's certification as an adult gerontology nurse practitioner. She will be completing her doctorate of nursing practice in adult gerontology at the University of South Florida, graduating in December 2018.

2. Falls in the Older Adult Population: Risk Assessment and Intervention

Lauren Perrotta, BS, Exercise Science, Doctoral Student of Physical Therapy at the University of South Florida, Morsani College of Medicine, School of Physical Therapy and Rehabilitation Sciences

This talk will describe risk factors related to one of the greatest health care crises presenting globally: falls. Risk factors are multi-factorial and both extrinsic and intrinsic and are greatly associated with fall reduction. Physical therapy's role in falls is integral to its prevention, and the CDC has created a STEADI initiative to address this global health crisis.

Bio: Lauren Perrotta is highly interested in geriatrics and orthopedics and is entering her third year of physical therapy school, with clinical experience in geriatrics and orthopedics, under the mentorship of orthopedic and sports and geriatric specialists board certified in their respective specialties.

3. The Future of Pharmacogenomics in Long-Term and Post-Acute Care

Samantha Quigley, BS, Biomedical Sciences, Student Pharmacist at University of Florida

The content will cover the basics of pharmacogenomics and its potential impact on long-term care. As of now, pharmacogenomics play a minute (if any) role in this population, but this is likely to change in the near future. Pharmacogenomics research has already proved an excellent tool in the fields of oncology and psychiatry, but can be applied to any medicines known to have a strong association with CYP metabolisms. The goal of this presentation will be to enlighten the audience as to the current state and potential future of this field as it pertains to their patient population.

Bio: Samantha Quigley is a fourth-year pharmacy student with a bachelor's degree in biomedical sciences with a focus in mathematics. Her primary experience has been working in retail pharmacy in The Villages, Florida, where she was introduced to the field of geriatrics. She is currently on her rotations for her last year of pharmacy school and plans to pursue a career as a consultant pharmacist.

4. When it Really May be a Zebra: Atypical Presentation of Illness in the Elderly

Cassandra Vannes, MS, ARNP, GNP-BC, AOCNP, Doctoral Student of Nursing Services at the University of South Florida, College of Nursing (graduated August 2018)

Subtle changes like decrease in function, fall, or diminished appetite may be the first signs of illness in an older adult. Because of atypical presentations, clinicians may miss life-threatening health issues such as a myocardial infarction or acute abdomen.

Bio: Cassandra Vannes worked as a direct care nurse and patient care manager in ICU for 10 years before receiving her gerontological nurse practitioner degree and certification. Her 25-year NP experiences include acute care and outpatient nephrology and cardiovascular medicine, and clinical and didactic instructor at USF College of Nursing for undergraduate and nurse practitioner students.

Her recent venture into oncology provides an opportunity to use her geriatric expertise as the Nurses Improving the Care of Healthsystem Elders (NICHE) coordinator at Moffitt Cancer Center. She serves on the Falls Committee, where her previous falls and injury prevention experience includes long-term care and community-dwelling elders with cardiovascular and renal disease. She has presented nationally on fall and injury prevention, delirium, and geriatric assessment. Vannes recently received her oncology nurse practitioner certification and is pursuing a doctorate of nursing practice. In addition to falls research, she is interested in exploring the role of delirium and falls in the oncology population.

5. The Soul Food Project: Fighting Loneliness Over Lunch

Brennan Ninesling, BS Biology, BA Spanish; Second-Year Medical Student at University of South Florida, Morsani College of Medicine

Since the 1960s, the elderly population in the United States has grown steadily. In addition to being at a greater risk for chronic disease, the elderly are also more vulnerable to being socially isolated and, thus, lonely. The University of South Florida, Morsani College of Medicine, is partnering with Meals on Wheels of Tampa to measure the effects of adding a volunteer visitor to a lunch program; that is, to see if eating meals with a medical student will decrease feelings of loneliness when compared with simply receiving meals. This small program, The Soul Food Project, could have major benefits for lonely members of the community as well as medical students themselves. We are receiving funding support from the Arnold P. Gold Humanism Society. Attendees will learn about the health care implications of loneliness and be presented with an example of a local effort to combat these feelings and improve the community as a whole.

Bio: Brennan Ninesling is a second-year medical student at the University of South Florida, Morsani College of Medicine. He is interested in infectious disease medicine as well as preventative medicine. A graduate of the University of Georgia in 2017, he participated in community outreach programs helping the elderly as an undergraduate and has been instrumental in creating similar programs at USF in Tampa.

Empiric Therapy with Tamoxifen in Demented Female with Symptomatic Enlarging Breast Tumor

Introduction and Objectives: Treatment options are often different in the long-term care population with dementia. Invasive tests and therapies are often more harmful than helpful. Families often limit treatment options as well. Mrs. B resides in a nursing facility with moderate to severe dementia. She was noted to have an enlarging firm mass in her breast consistent with breast malignancy.

Methods: Her daughter (HCS) declined sending her mother out of the facility for consults or procedures (imaging studies, biopsy). She did not want her mother to go through surgery, chemotherapy, or radiation therapy. When the mass started to show danger of eroding the skin and causing discomfort to the patient, management options were discussed. Pain medications could be offered but would cause adverse side effects including constipation, fall risks, and worsening confusion. Pain medicines would also not prevent the cancer from continuing to grow, eventually eroding the skin and creating additional issues with wound management, increased pain, and odor.

Results: Despite being unaware of whether her tumor was a hormone receptor (HR)-positive metastatic breast cancer, the daughter allowed the instigation of empiric therapy with tamoxifen after understanding risk and benefits.

Conclusion: Mrs. B. had a marked response to tamoxifen, with shrinkage of the tumor, resolution of discomfort, and no apparent adverse effects.

An Overview of Sexually Transmitted Disease Rates in Broward County's Geriatric Population

Introduction and Objectives: Sexually transmitted diseases (STD), such as Gonorrhea, Chlamydia, Syphilis, and HIV, are major health problems affecting many individuals. While there is a greater focus on controlling STD rates in younger generations, the geriatric population is also vulnerable to these diseases. In Broward County, FL, rates of STDs in populations over the age of 60 (60+) should be evaluated, and discussions on bettering physician-patient conversation on sexual health in elderly populations should begin.

Methods: Chlamydia, Gonorrhea, Syphilis, and HIV incidences between 2007 and 2017 were obtained from Florida Department of Health. Pearson coefficients between time and STD incidence were computed for both 60+ patients for the past 10 years. A one-tailed t-test was computed to compare the annual change in STD rate

in 60+ patients of Broward County to 60+ patients in Florida for the past 10 years.

Results: For 60+ patients in both Broward County and Florida, we found a positive correlation between time and incidence of Chlamydia, Gonorrhea, and Syphilis but a negative correlation for HIV. Only Chlamydia had a noticeable annual change in STD rate in the past 10 years compared to 60+ trend of the Florida population.

Conclusion: Our study shows that the incidence for those aged 60+ of Gonorrhea, Syphilis, and Chlamydia is on the rise in Florida. In Broward County, Chlamydia incidence is rising more quickly compared to Florida in 60+ patients. Follow-up studies should be conducted during annual visits for geriatric patients to evaluate the cause of the rise and presence of STDs in geriatric populations.

Improving Function in Blind/Visually Impaired Veterans Through iPad/iPhone

Introduction and Objectives: Blindness and visual impairment are significant problems in a growing number of people in the U.S., especially the elderly, leading to a negative impact on psycho-social needs, physical and emotional well-being, and overall quality of life. Many technological advances have allowed the development of new devices to improve function in this population, but there is very little data regarding the effectiveness of the iPad/iPhone. The Blind Rehabilitation Center at the West Palm Beach Veterans Affairs Medical Center has implemented and structured a unique program to train and educate veterans with blindness or visual impairment in the use of many devices, including the iPad/iPhone in improving their ability to function independently.

Methods: To determine the impact on function in this group, the Blind Rehabilitation Center measured outcomes in function using the Functional Independence Measure (FIM). An increase of at least 2 points on the FIM before and after the one-month course was considered significant.

Results: 240 veterans were trained in the iPad/iPhone use between 2014 and 2018, including 166/240 (69%) 65 years or older. Significant improvements were found in 194/240 (81%) in areas of orientation to device, accessibility, settings, home screen management, organization, email, Safari, iTunes, Siri, voiceover, accessible apps, allowing the individuals to perform such tasks as determining color of objects, accessing bank accounts, facial recognition, communication with friends and family, determining prices of store goods, and GPS orientation.

Conclusion: Training and education in iPad/iPhone use in the blind and visually impaired can have a major impact on function and QOL. These findings are pertinent to individuals at home, in independent living, in residents in ALFs, or even those in nursing facilities with mild cognitive impairment.

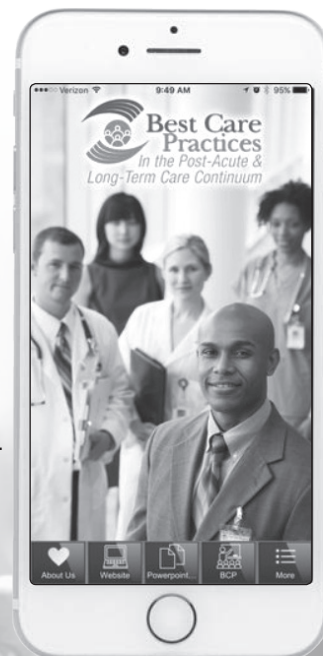
