

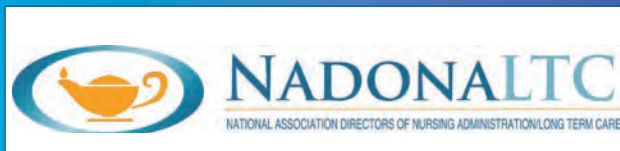

### **#103: Enhancing Clinical Competencies ~ Look Before You Leap (3 hours)**

**Overview:** As a foundation of this workshop, we will focus on the key medical practitioner role in strengthening care quality in the nursing home. We will reference the American Medical Directors Association on-line attending physician competencies curriculum, completed in 2016. We will use multiple case examples to define the optimal approach to clinical reasoning and problem solving. Case-based learning will also be implemented to demonstrate how an effective care delivery process (recognition, cause identification/diagnosis, management, monitoring) is key to providing safe, effective patient-centered care. In addition, results of a national survey of Post-Acute and Long-Term Care (PALTC) attending physicians focused on job analysis will be reviewed, identifying the most important task and associated knowledge statements, with correlation made to key competencies in this care setting. Finally, with case examples, a variety of approaches (top-down, bottom up, data driven) will be described that can help define and improve quality in the nursing home (NH). It will include specific instruction in the following areas:

- Review in depth how the care delivery process and diagnostic quality are relevant to all PALTC patients and additional care providers, not just medical practitioners
- Demonstrate how and why medical practitioners must lead the way in competent cause identification, with subsequent systematic approach to clinical reasoning and problem solving
- Define how PALTC could be streamlined and improved by adherence to simple clinical and management principles
- Review the results of a national survey of PALTC attending physicians, focused on job analysis (JA)
- Identify the most important Task and Knowledge statements from this survey and correlate to key competencies in this setting
- Understand how quality is defined and operationalized in the NH
- Compare and contrast the advantages of a top-down and bottom-up approach to quality improvement in the NH
