Best Care Practices in the Post-Acute & Long-Term Care Continuum 2022 (BCP) will be held Nov. 3-6, 2022, at **Loews Portofino Bay Hotel at Universal Orlando**, 5601 Universal Blvd., Orlando, FL 32819. Joint-providership is through **AMDA – The Society for Post-Acute and Long-Term Care Medicine** and **FMDA – The Florida Society for Post-Acute and Long-Term Care Medicine** and is planned in collaboration with Florida Chapters of GAPNA, NADONA, and FGS. BCP will also feature **FMDA's 31st Annual Conference**.

Due to the success of previous years' efforts, we are once again offering opportunities for interested organizations to hold non-CME/CPE/CE educational programs in conjunction with this annual program. We expect to host between 150 and 225 physicians, physician assistants, pharmacists, advanced practice nurses, directors of nursing, and other senior health care professionals seeking the latest in clinical and practice-oriented information.

Companies funding program proposals **must be** exhibitors and/or official supporters of **Best Care Practices in the Post-Acute & Long-Term Care Continuum 2022**. All external programming intended for attendees of this meeting must be submitted in the form of an application. Please be advised that no outside events can be held at or in conjunction with the conference without prior approval.

Product Theaters — Non-CME/CPE/CE Program Opportunities:

- There are six (6) non-CME lunch- and dinner-presentation slots for companies that would like to host registered attendees of this conference.
- The topic for the presentation is yours to choose. The speaker choice is yours. The menu selection is yours, as well.
- We will help you secure a private room at the conference hotel, promote your event to our attendees, facilitate onsite sign-ups, and help make your event successful. However, our efforts are only a supplement to your own marketing plans to aggressively promote your product theater.
- In addition, we will include the following audiovisual equipment, if requested: **1. Laptop, 2. Digital projector, 3. Projection screen, 4. Wired mic.**

THURSDAY: There are two (2) total lunch- and dinner-presentation opportunities on the preconference day. There will be only one (1) luncheon available for the **11:50 a.m.-12:50 p.m.** time slot, and it must be open to all attendees.

Major CME presentations are already scheduled for Thursday, so the luncheons are a natural fit. Your luncheon will be preceded and/or followed by workshops so you can expect 25-50* practitioners in attendance. The administrative fee, which is payable in advance, is **\$6,295**.

There is also one (1) **6:30-7:30 p.m.** dinner slot, where you can expect 45-75* practitioners. The administrative fee, which is payable in advance is **\$8,925**.

FRIDAY: There are two (2) total lunch- and dinner-presentation opportunities — the first official day of the conference.

You can expect 60-85* practitioners in attendance. It is tentatively scheduled from **12 to 1 p.m.** and must be open to all attendees. The administrative fee, which is payable in advance, is **\$12,495**.

There is also one (1) **7:15-8:15 p.m.** dinner slot, where you can expect 40-65* practitioners. The administrative fee, which is payable in advance, is **\$11,595**.

SATURDAY: There are two (2) total lunch- and dinner-presentation opportunities. You can expect 75-100* practitioners in attendance at the luncheon, which is scheduled from **12 to 1 p.m.** and must be open to all attendees. The administrative fee, which is payable in advance, is **\$12,495**.

One (1) dinner program, which runs **7:45 to 8:45 p.m.**, may be scheduled after the Presidents' Wine & Cheese Reception, which ends at 7:30 p.m., **Saturday, Nov. 5**. This unique opportunity is available only to conference exhibitors or their representatives, and no other dinners will be allowed. You can expect 30-50* participants. The administrative fee, which is payable to FMDA in advance, is **\$9,695**.

FEES & EXPENSES: In addition to the administrative fee for each slot, the applicant is responsible for all expenses related to food and beverage, audiovisual equipment beyond what is included, and any speaker honorarium and/or speaker travel expenses, etc. * *These are estimates only. An absolute number of attendees is not guaranteed.*
